Summary:

On Sunday, September 4, 2022 at 2:55 PM, PO [REDACTED], DSN, 4719 was involved in a Leaving the Scene Accident at 105 S. Central Ave., Clayton, MO 63105. The crash occurred while entering the parking garage/Sally Port at the St. Louis County Family Courts building. Three overhead beams were struck by the vent on top of the van and the rear facing LED camera mounted over the back doors. The incident was captured on in car video via Avail Web. The strikes/scraping were clearly loud and distinguishable. PO [REDACTED] was clearly aware of the incident as she was observed looking up at the top of the van, in the area of the rear facing light that was damaged. Additionally, insulation was observed on the ground and PO [REDACTED] was observed gesturing to one of the female prisoners that the insulation came from the ceiling. These images were

captured on the rear facing camera from inside the van. For information regarding the Department Vehicle Accident involving Van 40, see Record ID 15302 for further information.

PO [REDACTED] failed to report the crash and "Left the scene of the accident". The damage was discovered on September 5, 2022 during a routine vehicle inspection and reported to Sgt. [REDACTED], DSN 3293. Wet, White insulation was observed sticking to the rear bumper and bracket holding the rear facing LED light. The light was aimed down with the broken wire pointed upwards.
